#### **Magnet Recognition Program®**

As Magnet® continues to evolve and 'raise the bar' for nursing excellence, the inclusion process for the Demographic Data Collection Tool (DDCT) was re-evaluated.

To assure equity in the qualifications of criteria in the constitution of accepting a certification, beginning January 1, 2024, ANCC Magnet® will limit inclusion **only** to board certifications that are accredited by certain accrediting bodies.

# Re-Establishing Baselines for Certification Rates

With the change in professional board certifications related to the 2023 Magnet® Application Manual, organizations may re-establish their baseline. To do this:

- Verify certifications for inclusion by ABSNC, NCCA, ISO 17-024 and ICAC.
- Remove all certifications that are not professional board certifications accredited or on the retired list.
- Calculate new baseline percentage of eligible certified nurses.
- Establish year one and year two goals.

Retired certifications that have been validated by ABSNC, NCCA, ISO 17024, and ICAC are accepted by the Magnet Program Office. A current list of accepted retired certifications is available through ANCC.

## ABOUT PATHWAY

The 2024 Pathway to Excellence® Standards was released on October 10, 2023. Organizations applying or re-applying for either designation are required to write to the new elements of performance in the 2024 manual beginning with the February 1, 2025 cycle.

When going through the Pathway to Excellence® designation process it is important to note that there may have been changes to the version of the Pathway Application Manual you are working from. Changes may be made to the Pathway Application Manual at any time, and applicants are required to review and comply with the requirements in the Pathway Application Manual and all Pathway Application Manual updates.

## PATHWAY PROCESS

An organization earns or renews the Pathway to Excellence® designation through a comprehensive review process.

Effective January 1, 2017, The Pathway to Excellence® designation is granted for 4 years.

Applying for the Pathway to Excellence® is a major commitment. Conducting a Self-Assessment of Organizational Culture is an effective first step in identifying the gap between the organization's current state and its desired goals.


